

# All Exteriors Holiday Housetop Giveaway 2024 Official Rules

1. SELECTION OF WINNER: On or about December 13, 2024, Sponsor will select the name of one (1) potential prize winner in a random drawing from among all entries received. The odds of winning depend on the total number of eligible entries received. Since each property is limited to one entry, all eligible participants have an equal chance of winning, provided their entry meets the eligibility criteria and is received by the deadline. The potential winner will be notified by telephone and email within twenty-four hours (24hours) of the drawing.

Any arbitration proceeding and any award or decision shall remain confidential between the parties and shall not be made public.
